Foreword

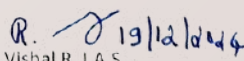

EXECUTIVE SUMMARY

The journey of the second cohort of The/Nudge Indian Administrative Fellowship in Karnataka has been one of learning, collaboration, and innovation. Through their expertise in problem-solving, solution design, technology expertise, stakeholder engagement, and with collaborative efforts across teams, the Fellows delivered significant results.

These include enhancing the State's Single Window System for investments, conceptualising and securing funding for the MSME (Micro, Small, and Medium Enterprise) portal under World Bank funded RAMP (Raising and Accelerating MSME Performance) scheme, and launching a Learning Management System for Anganwadi workers. The cohort also enhanced the Yuvakanaja youth portal, providing comprehensive information on youth schemes and engaging over three lakh users, with one lakh thirty thousand profiles created.

Online sessions via Arivu Kendras reached over ten lakh children and youth, offering life skills, career guidance, and creative activities. Fellows further conceptualized technology solutions for maternal health, child protection, digital libraries, and governance of Solid Waste Management leveraging Digital Public Goods (DPG), while establishing critical partnerships to bring these solutions to life. They have facilitated industry connections for job fairs, conducted a feasibility study for women's credit empowerment, and mobilised Corporate Social Responsibility (CSR) partnerships to support education, health, and water sustainability initiatives in Karnataka.

These outcomes are a testament to the commitment of both the Fellows and the government departments they worked with. As we prepare to launch the third cohort in Karnataka, I extend my heartfelt gratitude to the Government of Karnataka, the department officials, and the Fellows for laying a robust foundation.

Revamped Single Window Clearance System (SWS) for the industries in Karnataka

The context

Karnataka is a key driver of India's development, hosting over 400 multinational companies and leading in software exports, renewable energy, aerospace and defense and R&D sectors. Karnataka is known to be a prime destination for industrial investments. The Single-Window Clearance System (SWS) facilitated by Karnataka Udyog Mitra (KUM) enables access to critical information on policies, schemes, and providing timely clearances and in-principle approvals for investment proposals; such as approvals for land use, construction, environmental clearances, etc. However, based on feedback from industries and benchmarking against other states, there was a recognised need for enhancements to further digitise and streamline the system to increase Ease of Doing Business in the state.

The solution

On behalf of the Commerce and Industries department, the fellow worked with Microsoft and E&Y to revamp and digitise the State-level Single Window Clearance System (SWS) which aims to simplify the investment approval process for potential investors and enhance the efficiency, transparency, and effectiveness of over 138 G2B services provided by over 30 participating departments for industries in the state.

The key features of the solution are:

- Unification and digitisation of 138+ Business Services across 30 departments on a single platform
- Complete digital Lifecycle management of approvals and fee payments
- AI powered multilingual and multi-channel Chatbot
- Digital wizards, tools and how-to videos to assist investors
- Approvals for over 45 district level business services, bringing MSME related proposals under the purview of SWS
- Increased Transparency and time-bound SLAs via integration with SAKALA

Fellow's contributions & key results



Managed the program on behalf of the department to achieve the on-time rollout of the project in collaboration with the technical implementation partner Microsoft and Project Monitoring Unit (PMU) partner E&Y.



Collaborated with over **30+ departments** to rationalise and **unify over 138 business services**. Preparation and **review of Application Programming Interface (API) specifications** to ensure the seamless two-way integration between the SWS and departmental systems.



Validated functional requirements for alignment with GOIs Business Reforms Action Plan (BRAP). **Enabled technology innovations** in terms of Geographical Information System (GIS) -based Industrial Information Systems, **proof-of-concept for a multilingual, multi-channel AI-based Chatbot**.

The way forward

With an implementation partner and a departmental program manager onboarded, the project with enhanced features is all set for development of Phase 2 and launch in February 2025.

MSME Sarthak Portal – A digital platform enabling growth of MSMEs in Karnataka

The context

Micro, Small, and Medium Enterprises (MSMEs) are the backbone of both the Indian economy and the state of Karnataka. They play a crucial role not only by making a significant contribution to the Gross Value Added (GVA) but also by driving employment, innovation, and entrepreneurship. Despite numerous policies, schemes, incentives, and support systems introduced by the Government of India and the Government of Karnataka, MSMEs continue to face significant challenges with respect to awareness of schemes, access to markets, credit, technology and infrastructure.

*65 % of MSMEs surveyed in Karnataka feel that there is a lack of knowledge and awareness on potential markets**

*76% of the respondents feel that limited availability of working capital products**

*74 % of MSMEs surveyed in Karnataka require financial assistance for the purpose of expansion and diversification or for the purpose of adoption of technology**

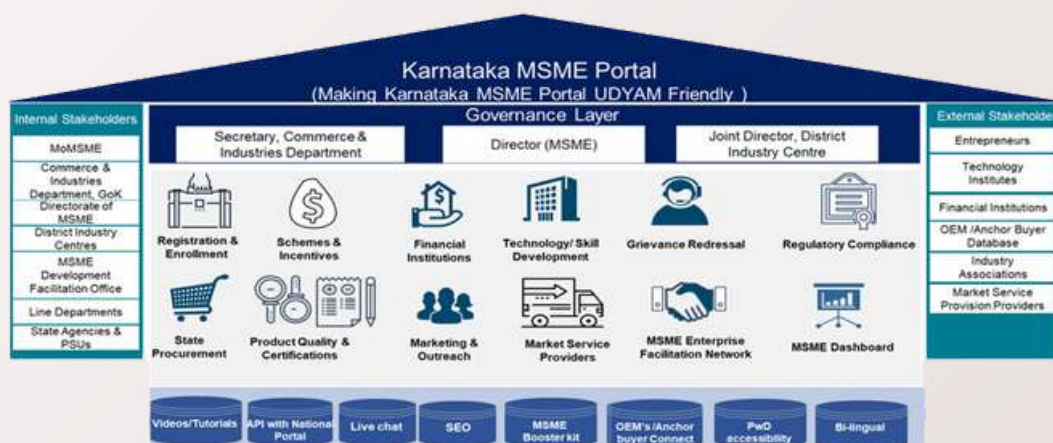
The solution

MSME Sarthak portal would see the State Government taking a more central role in using technology as an ecosystem enabler to address the challenges for the growth and sustainability of MSMEs. The platform intends to facilitate collaboration and transactions between MSMEs and key stakeholders such as government bodies, industry associations, academic institutions, service providers, financial entities, and mentors, in order to provide comprehensive support and development opportunities for MSMEs.

*Karnataka MSME Market Study, under Karnataka Strategic Investment Plan under World Bank supported Central Sector Scheme of GoI – Raising and Accelerating MSME Performance (RAMP).

Key features of the solution include:

- Providing information on markets, government policies, schemes, incentive claims, and available infrastructure
- Connecting MSMEs with marketplaces, government procurement opportunities, and innovation/vendor development
- Facilitating MSMEs in obtaining funding for business growth and daily operations.
- Offering guidance and expertise to MSMEs through mentors and various service providers
- Providing access to solutions for accounting, CRM, HCM, and skill upgradation.
- Integrating with national MSME portals and Karnataka's skill-connect portal for streamlined access to resources
- Allowing MSMEs to claim state government incentives and concessions online.
- Creating an engaging platform for MSMEs to connect, collaborate, and share knowledge
- Provides a digitised system for query resolution and mentorship support to MSMEs on various issues



Fellow's contributions and key results



Defined high-level functionality and **secured INR 15.84 crore in funding** for the development of the 'MSME Sarthak' portal under the World Bank-funded MSME-Ramp scheme.

The way forward

A tender to onboard the State's Program Implementation Unit (SPIU) for the MSME-RAMP program funded initiatives has already been released and processed. The selected SPIU agency will work with the department to design, develop & rollout the project.

Karnataka educational reforms and CSR-driven Government schools transformation initiative

The context

The Karnataka's government schools face significant challenges, including low enrollment, high dropout rates, and inadequate infrastructure, with over 18,000 schools having fewer than 30 students and 3,500 at risk of collapse. Issues such as poor WASH facilities, limited smart classrooms, lack of STEM labs, teacher shortages, and fragmented Corporate Social Responsibility (CSR) efforts further hinder quality education and equitable opportunities. These gaps lead to suboptimal learning outcomes.

The solution

The Karnataka Educational Reforms and CSR-driven government schools transformation initiative, addresses these challenges through innovative strategies like the Cluster Schools Concept consolidating smaller schools to optimise resources, build state-of-the-art infrastructure, and strengthen teacher capacity. Partnerships with CSR entities, Foundation, alongside grassroots organisations, aim to foster equitable access to quality education, improve learning outcomes, and create a sustainable model for rural education transformation. CSR conclave played a critical role in bringing together all the partners to enable large-scale development.

- *Optimisation of resources by merging smaller schools for greater viability*
- *State-of-the-art facilities, including STEM labs, smart classrooms, and vocational training setups*
- *Trained teachers in digital literacy, STEM, and modern pedagogy.*
- *Support of CSR entities and foundations for resources*
- *NGOs Partner for grassroots expertise and innovative education models*
- *Integrate fragmented CSR initiatives into comprehensive reforms*

Adoption of cluster school model and pilot in the Varuna constituency, Mysore, marking a significant step toward transformative education reforms. Launch of the 500 government schools adoption program. The context

Bangalore, once known as the "City of Lakes," faces an acute water crisis due to delayed rainfall, a rapidly depleting groundwater table, unchecked domestic and industrial pollution, and unsustainable urbanization. Conventional methods like de-silting fail to address root causes such as unregulated groundwater extraction and inadequate recharge mechanisms. Fragmented efforts among Corporate Social Responsibility (CSR) partners, government agencies, and academic institutions further hinder sustainable water management. Legal hurdles and misaligned priorities have slowed CSR engagement in critical rejuvenation projects. Key issues include severe groundwater depletion, pollution of water bodies, and ineffective rejuvenation methods that overlook long-term solutions. Limited adoption of innovative technologies, such as bioenzyme formulations and plant-based water purification, adds to the challenge.

The solution

To address these challenges, Jala Samruddhi: CSR-driven multidisciplinary research and water sustainability initiative was launched as a transformative program. This initiative aims to integrate corporate social responsibility (CSR) engagement, interdepartmental collaboration and multidisciplinary research through engagement of educational institutions to design and implement sustainable water management practices across Karnataka.

The project emphasises evidence-based, scalable, nature-based solutions, fostering collaboration among diverse stakeholders. With CSR funding, cutting-edge research, and evidence-driven approaches, the initiative aims to revive Bangalore's lakes and rivers, recharge its groundwater, and restore its ecological balance

Fellow's contributions and key results



Conceptualised and initiated the "Jala Samruddhi" project, integrating CSR funding, government schemes, and multidisciplinary research with a focus on sustainable, nature-based solutions for water rejuvenation. The context

Karnataka generates 9.17 lakh metric tons of waste annually, according to a recent report by the Central Pollution Control Board.* Significant improvements can be achieved in Solid Waste Management (SWM) by addressing the challenges of inadequate capacity building, limited public awareness, poor governance, weak policy enforcement, and fragmented coordination.

Gram Panchayats (GPs) in Karnataka face challenges in effective and efficient tracking of waste collection, segregation, transportation, and disposal of different types of waste. There is a huge opportunity to enable effective waste management tracking and governance through technology.

The solution

A first of its kind in the Country, the initiative leverages DIGIT Digital Public Good (DPG) to enable grassroots-level transformation in SWM practices, improving their effectiveness and efficiency. The solution will enable data capture, systemic & comprehensive tracking and governance of end-to-end SWM process, improving service delivery and decision making.

The focus is to develop a comprehensive Digital Public Infrastructure (DPI) strategy, architecture and design to enable digital transformation of infrastructure, people, and processes to enable SWM activities across 5,951 GPs in Karnataka. The project will drive awareness on SWM processes & best practices through AR VR (Augmented Reality & Virtual Reality) based IEC (Information, Education & Communication) initiatives.

This effort establishes a robust foundation for expanding DPG adoption across the state for a variety of other applications.

Conceptualised technology-led innovation by utilizing digital public goods (DPG) to create a DPI strategy and roadmap, **enabling digital transformation of infrastructure, people, and processes** for SWM activities across 5,951 Gram Panchayats (GPs) in Karnataka.



The solution was strengthened through insights gained from **extensive intra- and inter-state field visits**, inputs from organizations such as Saahas, Hasiru Dala Innovations, industry experts and mentors, as well as technical organisations like TROIS (Kerala), KELTRON, BEL, and corporate partners.



Advocated and enabled the solution through extensive stakeholder interactions, collaborating with Grant Thornton to **develop functional requirements**, and facilitated **onboarding of the System Integrator (SI) partner**, Centre for Smart Governance (CSG) and Egov Foundation, DIGIT Platform.



Introduced innovative IEC (Information, Education & Communication) by developing a **VR-based application to enhance the capacity of SHGs and the SWM workforce** on end-to-end SWM processes and best practices, by driving industry-academy collaboration.

The way forward

The DPI partners are onboarded and working with the department nodal officer to drive DPI program implementation and IEC VR enablement. The technical and functional committee is formed including experts from various organisations for governance and implementation of the DPI.

The context

Karnataka has 5,895 Arivu Kendra (rural libraries) with 5767 being digital libraries, acting as knowledge hubs, catering to the learning needs of children, youth and rural communities. Various organisations offer content and resources across sectors such as agriculture, healthcare, digital literacy, vocational trainings, etc. Arivu Kendra faces challenges with content fatigue, repetitive materials, difficulty in refreshing high-quality content, limited topic coverage, and a lack of variety in resources. Librarians face coordination challenges, and the appropriate content often fails to reach the intended audience, limiting the quality content to a few gram panchayats. There is a need to centralise essential resources across all the rural communities.

The solution

The project aims to develop a unified digital public infrastructure platform that provides essential educational and skill-building resources that will significantly enhance literacy and access of relevant resources for rural communities. Leveraging the building blocks of the Sunbird Platform, developed by the Ek Step Foundation, the solution will address regional needs and seamlessly integrate content from NGOs, the Arivu Kendra soft skill & literacy enhancement program for rural children (12- 18yrs) and other department-approved resources.

Enabling employment opportunities for youth through job fairs

Status: 58 companies successfully onboarded for the KSDC Job Fairs.

The context

The Karnataka Skill Development Corporation (KSDC) works actively with youth, enrolling them in training and certification programs for a diverse range of job roles. These include traditional trades like plumbing, electrical work, and masonry, as well as modern professions such as digital marketing and data entry. Additionally, KSDC has a specialised unit for facilitating overseas job placements.

Despite the significant efforts by the government and the department to equip the youth for employment, the actual outcomes fall short of expectations. Enrollment and training initiatives are substantial, yet the conversion to job placements remains relatively low. This presents an important opportunity to enhance collaboration with industries across various sectors within the state. Strengthening these partnerships can help bridge the gap between training and employment while fostering both job creation and entrepreneurial ventures, ultimately driving economic progress in Karnataka.

The solution

To address youth unemployment, the KSDC organises Udyoga Melas (Job Fairs) at the district and taluk levels. These events are designed to connect young job seekers—particularly fresh graduates and those with limited experience—with potential employers. They play a crucial role in career development and tackling unemployment across the state. Over the past 18 months, the Skill Connect team at KSDC, including the Fellow, has been instrumental in organising these job fairs. Out of 1,322 companies across five job fairs, the Fellow's contributions have included onboarding 58 companies from the services, technology, banking, financial services, and insurance (BFSI) sectors, enhancing the registration process through technological integration and improving overall event efficiency.

Empowering rural women through micro-entrepreneurship in waste management

Status: Report submitted with recommendations for a Plastic Recycling unit at Gargeshwari GP to boost women's role in SWM.

The context

In terms of employment and entrepreneurship opportunities for women, in rural Karnataka, women in self-help groups (SHGs) have been actively involved in solid waste management (SWM) at the gram panchayat (GP) level, creating an opportunity to develop a sustainable, scalable micro-entrepreneurship model. This initiative aims to further empower SHG members by establishing a commercially viable model within SWM.

The solution

To explore the feasibility of a commercially viable, sustainable, and scalable micro-entrepreneurship model for solid waste management (SWM) at the gram panchayat (GP) level, the Fellow conducted field visits to four GPs across three districts: Honaganahalli and Gummanahalli in Pandavapura (Mandya district), Gargeshwari in T. Narasipura (Mysuru district), and Vandse in Kundapura (Udupi district). The goal of these visits was to identify best practices and challenges in SWM managed by women's self-help groups (SHGs) and assess the potential for a micro-entrepreneurial model. The findings culminated in a report recommending the establishment of a plastic recycling unit at Gargeshwari GP, Mysuru district, aimed at enhancing women's participation in SWM and providing a sustainable waste management model.



Fellow's contributions & key results



Submitted a report with **10 key recommendations**, including a proposed **micro-enterprise model** to boost women's participation in **SWM**, specifically through a **plastic recycling unit** at Gargeshwari GP.

The way forward

A pilot is planned in Gargeshwari gram panchayat in collaboration with the Mysore zilla panchayat to take forward the implementation of the recommendations.



Improving women's access to credit

Study feasibility for setting up a Multipurpose Credit Cooperative Society for SHG members in Karnataka

Skill Development, Entrepreneurship and Livelihood Department

Status: Concept note on the feasibility of establishing a Multipurpose Credit Cooperative Society for SHG members in Karnataka, along with a comprehensive outline of the required processes and steps, has been submitted to the Mission Director, National Livelihood Mission (NLM), Karnataka.

The context

Economic empowerment of women is crucial for broader societal development. In Karnataka, there is a pressing need for a robust financial infrastructure that supports women's financial inclusion. Access to financial services for women remains limited, hindering their economic independence. To address this gap, a study was initiated to explore the possibility of establishing a specialised financial institution, such as a Multipurpose Credit Cooperative Society for SHG members in Karnataka. This initiative is inspired by successful model like the Stree Nidhi Credit Cooperative Federation Ltd. in Telangana, which has demonstrated the significant impact of women-focused financial institutions in fostering economic empowerment. The study aimed to assess the feasibility of replicating these models in Karnataka, with a particular focus on the Rajasthan Mahila Nidhi Credit Cooperative Federation Ltd. in Jaipur.

The solution

Building on the findings of the feasibility study for women's financial empowerment, a proposal is being developed to establish a Multipurpose Credit Cooperative Society for SHG members in Karnataka. This proposal follows a field visit to the Rajasthan Mahila Nidhi in Jaipur, conducted by the NLM Karnataka team and the Fellow. The proposed solution aims to create a sustainable, women-led financial institution in Karnataka, improving women's access to financial resources and services, thereby fostering their economic empowerment.

The way forward

The concept note and proposed structure along with the recommendations have been submitted to the Mission Director, NLM, Karnataka, and the subsequent steps are currently under review.

Empowering SHGs, expanding market reach

Enabling market linkages and expanding opportunities for Self-Help Group (SHGs) products

Skill Development, Entrepreneurship and Livelihood Department

Status: MoU has been signed between Bengaluru Metro Rail Corporation Limited (BMRCL) – the venue for Bengaluru Santhe, and Karnataka Rural Infrastructure Development Limited (KRIDL) and KSRLPS - Sanjeevini (NLM, Karnataka) for the execution of Bengaluru Santhe.

The context

Rural women's Self-Help Groups (SHGs) under the National Livelihoods Mission (NLM) produce a variety of products at home but face significant challenges in accessing broader markets. Their market reach is largely confined to local Talukas or districts, limiting their sales opportunities and income potential. To address this, the project aimed to expand their market access through both online and offline channels. The intervention involved collaborating with a specialised marketing agency, Mysore Sales International Ltd. (MSIL), recognised for its expertise in branding and promoting government products. Additionally, market linkages were strengthened through the creation of Sanjeevini Marts at district, taluka, and gram panchayat levels to enhance sales opportunities and broaden the market footprint for SHG products.

The solution

The fellow played a key role in advancing the project by leading the development of the concept note and business plan for 'Bengaluru Santhe,' a proposed marketplace at SV Road Metro Station in Bengaluru for showcasing SHG products. The fellow coordinated efforts to identify suitable locations for additional marketplaces, including a supermarket in Belagavi, and facilitated partnerships with various stakeholders. This included collaborating with Mysore Sales International Ltd. (MSIL) as the technical and marketing service provider and onboarding Nanomedia as the execution partner. Furthermore, the fellow worked closely with the partner agency and the Bangalore Metro Rail Corporation Limited (BMRCL) to finalise the project's details. In alignment with the directives from the Additional Chief Secretary (ACS), SDEL Department, and the Mission Director of the Karnataka State Rural Livelihood Promotion Society (KSRLPS) - Sanjeevini, the project was handed over to the department for further execution.

The way forward

The project is underway, with an MoU signed between BMRCL and KSRLPS - Sanjeevini for the launch of Bengaluru Santhe. The department will continue driving the project to create a sustainable marketplace, expanding sales opportunities and market access for rural women SHGs.

Digital learning

Learning Management System for ICDS field functionaries

Department of Women and Child Development

Status: Launched with 12 learning modules. Trainings conducted for 900+ staff.

Partners: Infosys, Makkala Jagriti, Foundation for Mother and Child Health

The context

The Integrated Child Development Scheme (ICDS) within Women and Child Development department aims to enhance early childhood care, nutrition, and maternal health through Anganwadi centers. However, audits and research have identified significant skill gaps among Anganwadi Workers (AWWs), in Early Childhood Care and Education (ECCE). Field visits, focus group discussion and personal interviews with supervisors and Anganwadi workers by the Fellow show many workers lack clarity on what to teach and how to teach children at Anganwadi Centers, adversely impacting service delivery. Furthermore, no formal capacity-building training has been conducted for AWWs since COVID-19, creating critical knowledge gaps and limiting their effectiveness. These findings highlight critical training deficiencies among Anganwadi personnel that, if left unaddressed, could compromise the ICDS program's impact.

The solution

To address these challenges, we conceptualised a Learning Management System (LMS) to foster the continuous development of AWWs, helpers, and supervisors by equipping them with the necessary knowledge and skills to provide high-quality care and services. For this purpose, Infosys Springboard was selected as the LMS solution and is currently being implemented. This multilingual, app-based platform gives flexibility and ownership to the department to create and upload interactive modules, generate certificates, and build a resource repository, fostering continuous skill development. The Department can leverage real-time monitoring tools to track training progress and make data-driven interventions.

By bridging knowledge gaps, promoting digital literacy, and fostering professional growth, the LMS will empower Anganwadi personnel, significantly improving ICDS program outcomes.

Fellow's contributions and key results



Extensive field visits and meetings conducted with supervisors, AWWs, and WCD stakeholders to **identify capacity-building needs, training requirements, and digital content** for LMS adoption.



MOU was signed between Infosys and CEG to utilize Infosys Springboard. **Onboarded Makkala Jagriti and Foundation for Mother and Child Health (FMCH)** to offer digital content on ECCE, nutrition, and breastfeeding. LMS was launched with rich content.



400 supervisors, Child Development Project Officers (CDPOs), and Deputy Directors (DDs) trained across Karnataka via Google Meet on usage of Springboard. On-field workshops conducted in **six districts Chamarajnagar, Mandya, Bidar, Kalburgi, Belagavi and Chikbalapur** training over **400 supervisors and 100 AWWs** on LMS usage, email creation, and digital literacy.

The way forward

- Live sessions on digital literacy and LMS is planned through the Panchayat Raj studio
- Department stakeholders to continue to drive the adoption in collaboration with NGO partners.
- Springboard will support future training on topics like child marriage, POSH, ethics, and compliance, tailored to departmental needs.
- The LMS is scalable to other government departments for capacity building, improving service delivery

The LMS has the potential to reach over 120,000 field functionaries, improving service delivery and impacting 4 million beneficiaries

Ending child marriage

Next Generation 'Surakshini' Application for enhanced monitoring and follow up of child marriage cases

Department of Women and Child Development

Implementation partner onboarding in progress.

The context

Child marriage remains a critical concern in Karnataka, with 21% of women aged 20-24 marrying before 18, as reported by National Family Health Survey (NFHS-5). The Child Helpline (1098) captures most cases. However, there is a lack of follow-up by Child Marriage Protection Officers under Integrated Child Protection Scheme (ICPS) on these cases, until the girl turns 18. To address this, the Karnataka government launched the Surakshini website, but its effectiveness is hindered by operational issues such as poor data integration from sources like the Child Helpline (CHL-1098), police reports, and in-person complaints. This results in duplicate entries, missed cases, and tracking errors.

Additionally, interdepartmental coordination is weak, and user engagement suffers due to inadequate training, interface design challenges, shared logins, and limited mobile accessibility. These barriers undermine its potential to effectively combat child marriage.

According to NFHS-5 (National Family Health Survey), In Karnataka, twenty-one percent of women aged 20-24 years got married before attaining the legal minimum age of 18 years, a figure that has remained unchanged since NFHS-4. This stagnation highlights the persistent challenge of addressing child marriage in the state

The solution

The solution builds a robust data integration system to ensure holistic case tracking and streamlined responses. The system will automate data entry where applicable and establish structured systems for escalated cases enhancing efficiency. Regular reconciliation and training will improve data accuracy, while incorporating key departments into the child welfare network will boost coordination. Non-monetary incentives like certificates and recognition for supervisors, user-specific credentials for data security, and mobile integration for notifications and reminders will foster engagement, collaboration, and timely responses to combat child marriage effectively.

Fellow's contributions and key results



Evaluated workflows at the ICPS (Integrated Child Protection Scheme) control room, reviewed the Surakshini application, and identified gaps, including the lack of a Standard Operating Procedure (SOP). Conceptualised technical and process improvements based on these insights. Developed high level **business requirement document, work orders and a formal communication** to start work by CDAC.

The context

The Integrated Child Protection Scheme (ICPS) in Karnataka addresses critical child protection challenges amidst rising cases of child abuse, trafficking, and neglect. Despite the Juvenile Justice Act, 2015, emphasising holistic child care and protection, systemic gaps hinder effective implementation. Key challenges include fragmented and non-digitised data across stakeholders like Child Welfare Committees (CWCs), District Child Protection Units (DCPUs), and Child Care Institutions (CCIs), limiting real-time insights and decision-making. Existing platforms, such as the Mission Vatsalya portal, face design flaws, insufficient training, and lack of scaling, reducing their effectiveness. Additionally, the absence of a dedicated Project Management Unit (PMU) exacerbates these issues, resulting in delayed interventions and inadequate accountability.

The solution

The proposed solution aims to digitally transform the child protection ecosystem in Karnataka through the development of an **End-to-End Unified Child Protection System (UCPS)**. This system will serve as a single, integrated platform connecting all stakeholders involved in the care and protection of vulnerable children, enabling seamless service delivery and advanced decision-making capabilities.

This integrated digital platform conceptualized in collaboration with pro-bono support from Deloitte and Amazon Web Services (AWS) aims to unify case management, service tracking, monitoring, and data analytics, enabling seamless coordination, real-time decision-making, and enhanced service delivery for vulnerable children across Karnataka.

- *Leverages cloud infrastructure and BI dashboards for real-time insights, predictive analytics, and evidence-based policymaking*
- *Digitizes legacy data from CWCs, CCIs, and DCPUs, integrating historical records into UCPS for comprehensive tracking and analysis.*
- *Unique identifiers for streamlined child registration, rescue, rehabilitation, and follow-ups process*
- *Real-time CCI capacity updates to ensure equitable distribution and optimal resource use*
- *Automated workflows to monitor home visits, foster care, sponsorships, and aftercare services*
- *UCPS will enhance Mission Vatsalya portal, improving functionality and interoperability with other systems*

Fellow's contributions and key results



Onboarded and partnered with AWS (Amazon Web Services) and Deloitte pro bono, to explore solutions, and advanced data analytics tools, and conduct a comprehensive assessment of existing ICPS workflows.



Conducted an **in-depth assessment** in collaboration with Deloitte of the existing ICPS ecosystem to **identify gaps** in processes and workflows. Engaged with stakeholders like CWCs, CCIs, DCPUs, CHLs, and JJBs through **workshops and field visits** to understand their needs, challenges, and validate findings. **Presented and submitted solutions and recommendations** to the Directorate and WCD Secretary for approval. **Approvals received for developing detailed documentation of solutions and the next phase of the project.**



Drafted **technical and operational frameworks** for further study and potential digitisation strategies. Fellow engaged with AWS and Deloitte teams and proposed an end-to-end **Unified Child Protection System (UCPS)**. An executive note and final project proposal with detail of the solution drafted and submitted and approved by the ICPS Director.

The way forward

Once the project gets final approval/Cabinet approval Deloitte will set up a PMU within the department and will create the solution whereas AWS will provide server support.

Advancing maternal health services

State-owned maternal health application enhanced with real-time AI analytics and AI chatbot

Status: Pilot under approval for Bidar and Kalaburagi districts

Partners: Johns Hopkins Program for International Education in Gynecology and Obstetrics (JHPIEGO), Amazon Web Services (AWS)

The context

An in-depth analysis of the data on maternal and child health services along with the underlying IT systems, uncovered significant challenges in data capture, management, and reporting of data. These issues can impede the delivery of timely and effective maternal healthcare services which further impact maternal health outcomes.

Key challenges include inefficiencies in field-level data workflows, leading to duplication, inaccuracies, and data fragmentation. These issues disrupt continuity of care between community and higher healthcare facilities. A notable gap exists in digitisation at the intrapartum stage, a critical period for ensuring maternal and neonatal safety. Manual data entry processes, in labor rooms, can further contribute to errors, lack of data for analysis and decision support.

The existing Government of India (GOI) applications did not fully align with the specific needs and context of Karnataka. These systems lack integration and advanced features such as High-Risk Pregnancy (HRP) tagging, referral tracking, and intelligent analytics. These limitations reduce the ability to generate actionable insights for planning and interventions, underscoring the need for a state-owned maternal health IT system tailored to the state's unique requirements.

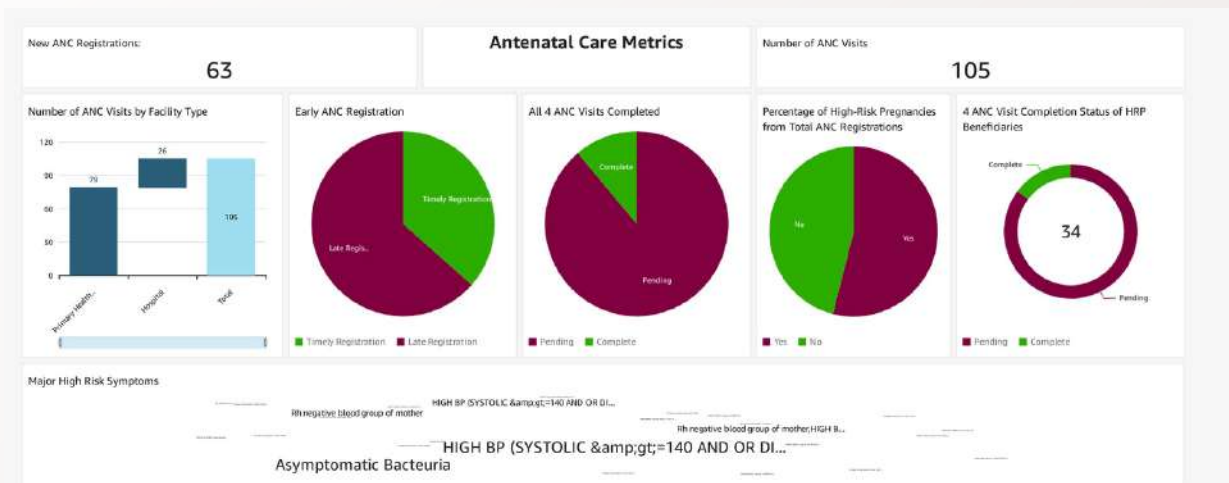


The solution

The fellow facilitated a collaboration between JHPIEGO and AWS to pilot an advanced maternal health application, combining JHPIEGO's expertise in obstetrics and digital health with AWS's cutting-edge AI and analytics. This partnership aims to improve service delivery and maternal outcomes through data-driven insights, real-time monitoring, and AI-powered tools. The solution is customisable to the state's needs and enhances operational efficiency, prioritisation, and planning at the field level and insight generation at administrator level. The ABDM compliant solution ensures integration with existing government platforms for interoperability, scalability and sustainability. The source code of the application is being offered to Indian States free-of-cost by JHPIEGO.

Fellow's contributions and key results



Conducted a **needs assessment** to identify **opportunities and gaps** in the department's Maternal Health **IT systems and service delivery processes**. Evaluated existing solutions and vendors to **plan a course of action** for the department.



Collaborated with AWS and JHPIEGO to plan a **pilot** of the solution in 2 districts (Bidar and Kalaburagi).



Defined functional requirements and **enabled proof-of-concept design** for the **AI-enabled dashboard, query builder and chatbot** that can provide insights, reduce administrative burden and plan interventions at administrative levels.

The way forward

The pilot is being planned and under approval for Bidar and Kalaburagi districts. The proposal for state wide implementation has been submitted for cabinet approval.

Improving awareness and access to government schemes among youth

Yuvakanaja - unified portal and notification system for youth programs by the Government of Karnataka

Department of Youth Empowerment and Sports

Status: Yuvakanaja portal redesigned, enhanced and moved to State Data Center

The context

There are various schemes for the youth offered by the Government. These are all spread across various Departments- Youth Empowerment and Sports, Primary and Secondary Education, Health and Family Welfare, Social Welfare and Backward Class Dept, Higher Education, Skill Development and so on. The existing youth portal Yuvakanaja.in providing information on these schemes as a single source needed upgrade in terms of user experience, features and the up-to-date information from various departments.

The solution

The central youth portal was enhanced to provide comprehensive, up-to-date data from all relevant departments, while improving its user experience and accessibility. The platform offers a user-friendly interface where youth can easily find information related to education, career development, skill development, employment, entrepreneurship, scholarships, awards, sports, and job opportunities. Information is categorised both by topic and by the respective department offering the schemes. The upgraded portal aims to boost the utilisation of government programs, contributing to better youth development outcomes and improved youth development indices for the state.

The portal has transformed from an outdated platform with under 10,000 users to a dynamic hub serving over 300,000 users. It now boasts 115,000 youth profiles, ensuring personalised notifications about job fairs, skill training, startup funding programs, and self-employment support.



Fellow's contributions & key results



Revamped and updated portal with user friendly features and information on + **500 youth programs** from **45 government departments**, ensuring accuracy and relevance.



Implemented a new personalized profile creation feature allowing users to access tailored content on relevant youth schemes in order to enhance user engagement.



Conducted orientation sessions for key stakeholders, reaching **474 degree Colleges, 9000 NSS volunteers and 4000+ Grama Panchayat Librarians.**



The earlier spend of INR 50 lakhs for this portal was minimized and the Government of Karnataka got a **refund of about INR 35 lakhs** from the vendor (through NIMHANS).

The way forward

- A Nodal Officer will be designated within the department to drive the initiative forward
- NGOs have committed to maintaining the portal's information by engaging youth interns for ongoing updates and management

Project Title: Business performance review to revitalise government corporations for the development of coir, handlooms and handicrafts - KSCDC, KHDC and KSHDC

Project overview: The project focused on conducting comprehensive Business Performance Reviews for three Karnataka state entities namely, Karnataka State Coir Development Corporation (KSCDC), Karnataka Handloom Development Corporation (KHDC) and Karnataka State Handicrafts Development Corporation (KSHDC). The review encompassed in-depth analysis of all areas including strategy, sales, marketing, financials, operations, IT adoption, supply chain efficiency, product-mix, market-mix and other pertinent factors. The output were detailed presentations for each Corporation outlining findings and analysis along with a suggested action plan to address challenges and capitalise on opportunities within each Corporation.

Status and way forward: The action plans with ~16 recommendations were submitted to the department and all have been accepted by concerned corporations and department stakeholders. They are in various stages of implementation.

Project Title: Malnutrition and anemia eradication initiative in Karnataka

Project overview: Karnataka faces persistent challenges of malnutrition and anemia, particularly affecting children, pregnant women, and adolescent girls, due to poor dietary diversity, socio-economic disparities, and limited healthcare access. The Malnutrition and Anemia Eradication Initiative addresses these issues through dietary interventions with nutrient-rich millets, capacity building of Anganwadi workers, targeted data-driven actions, and public health education. By reducing anemia and malnutrition rates, the initiative aims to tackle the root causes of IMR and MMR, paving the way for a healthier Karnataka.

Status and way forward: Recommendation submitted with dietary chart, bajra has been incorporated into dietary programs with central government subsidies to enhance nutrition. Rolled out millet-based Ragi malt for approximately 4,000 children with Severe Acute Malnutrition (SAM) and Moderate Acute Malnutrition (MAM) in aspirational districts in collaboration with Annapurna Trust. Department will implement and Monitor the project progress.

Department: Planning, Programme Monitoring and Statistics Department

Project Title: Empowerment through digital transformation

Project overview: The Empowerment through Digital Transformation project addresses systemic e-governance challenges, including delays in service delivery from fragmented databases, KYC mismatches, Aadhaar errors, and insecure PII (Personally Identifiable Information) systems. The Gruhalakshmi scheme faced dormant accounts and incomplete KYC, hindering Direct Benefit transfers (DBTs), while the Akanksha CSR Portal dealt with SSL issues, authentication failures, and mismatched engagements. These challenges highlighted the urgent need for secure, scalable digital platforms to streamline services, ensure data accuracy, and foster participatory governance.

Status and way forward: Enhanced the Gruhalakshmi scheme delivery with geospatial and data analytics, developed secure PII protection applications, and coordinated digital banking solutions in collaboration with India Post Bank. Migrated and Enhanced the Akanksha CSR Portal, addressing SSL, authentication, and matchmaking features for CSR projects. Conducted Knowledge Transfer (KT) sessions with stakeholders, including UNDP and the CeG Web portal Team, to ensure smooth implementation of initiatives.

Project Title: Wayanad disaster management

Project overview: The recent tragic landslide in Wayanad on 30th July 2024, which resulted in significant loss of life and property, brought to the forefront the critical need for effective disaster preparedness and response mechanisms. The immediate response, led by the Government of Karnataka and coordinated by various public and private stakeholders, was commendable for its rapid mobilisation and effective distribution of essential resources. Under the leadership of Dr. Shalini Rajneesh, Chief Secretary-GOK, and with key contributions from various corporate entities and NGOs, the response efforts demonstrated a high level of coordination and resource mobilisation.

Status and way forward: The Fellow played a crucial role in the Wayanad relief efforts, by overseeing strategic planning and coordination among government agencies, NGOs, and private sector partners. He supported in mobilising resources, ensuring timely delivery of emergency supplies like water, PPE kits, and medical essentials, in collaboration with corporations such as Volvo and KIAL. The fellow managed logistics for transporting relief materials, engaged stakeholders to streamline communication, and liaised with state officials to enhance response efforts. Additionally, he gathered and reported data on resource distribution, ensuring transparency and effective use of supplies.

Department of Rural Development and Panchayati Raj

Project Title: Adoption of Kusina Mane (Creche)

Project overview: The Fellow played a key role in enabling adoption of 15 Kusina Manes by Rotary District 3191. The initiative aims to address key issues in child development, focusing on nutrition, infrastructure, and interactive educational activities, by adopting Kusina Manes in Ramnagara, Kolar & Bengaluru Rural.

Status and way forward: One year intervention plan has been prepared for the holistic development of child focusing in nutrition, early childhood.

Project Title: Panchayat Development Officer (PDO) transfer counselling application

Project overview: An internal application for Commissionerate was developed to improve efficiency of the PDO counseling and placement process across Gram Panchayats. Interns from Global Academy of Technology were onboarded, enabled on functional, technical and process requirements to develop and deliver the application.

Status and way forward: The application has been demonstrated and handed over to the department.

Project Title: GP Asset Monetisation - Revenue generation for GP for local self-governance.

Project overview: The project evaluated technology solutions for an inventory system to identify and monetise assets owned by each GP, enhancing their financial capacity to fund development projects. DPI has been identified as a promising solution for asset inventory and monetization. Pilots in 20 GPs will validate the plan.

Status and way forward: A committee has been formed to evaluate the solution and action plan.



Department of Skill Development, Entrepreneurship and Livelihood

Project title: Empowering Women: Strengthening financial security through small savings scheme

Project overview: The project aimed to enhance women's financial independence by introducing a secure savings scheme to replace unreliable chit funds. In collaboration with MSIL, a tailored small savings product with a tech-enabled application process was proposed. The fellow contributed by drafting the MoU, helping identify the four Gram Panchayats for the pilot, engaging with SHG members, and coordinating with MSIL to prepare the execution plan.

Status and way forward: The project is now overseen by NLM, who will decide on future actions.

Project title: Mapping Active BC Sakhis in Karnataka's Gram Panchayats to Scheduled Banks

Project overview: 'Mission One GP One BC Sakhi,' an initiative under NRLM, aims to promote digital finance and expand banking services in rural Karnataka by deploying trained women SHG members as Business Correspondents (BCs). This model enhances financial access, promotes inclusion, and integrates SHG accounts with regulators and Technology Service Providers (TSPs). The project focused on surveying Gram Panchayats to identify bank branches, assess BC Sakhi activity, and train eligible women to serve as BCs in underserved areas. The fellow played a key role in mapping Scheduled bank branches, ATMs, and BC Sakhis across the state.

Status and way forward: The findings of the mapping exercise have been shared with the MD, NLM, and are awaiting further consideration and action.



Department of Women and Child Development and Empowerment of Differently Abled and Senior Citizens

Project Title: Expand usage of Health & insurance, PMJJBY and PMSBY across Anganwadi workers and Helpers

Project overview: The project aims to enhance the adoption of health and insurance schemes, specifically PMJJBY (Pradhan Mantri Jeevan Jyoti Bima Yojana), PMSBY (Pradhan Mantri Suraksha Bima Yojana), and ABaRK (Ayushman Bharat Arogya Karnataka), among Anganwadi workers and helpers. The initiative focuses on identifying staff without access to these schemes and promoting enrollment through a systematic approach. A tech-enabled solution was initially proposed, but the approach evolved into a revised strategy of promoting and tracking adoption through Child Development Project Officer (CDPO) offices.

Status and way forward: To standardise enrollment tracking, data capture formats were designed and shared with Deputy Director-WCD and the WCD team. Coordination with the WCD Director ensured focus on tracking progress, and follow-ups gathered enrollment data for Anganwadi workers and helpers in PMJJBY, and PMSBY. Analysis identified gaps and discrepancies, leading to revisions in the data formats to minimise inconsistencies. The updated formats were sent to districts to recollect accurate enrollment data for AWWs and AWHs in PMJJBY, PMSBY, and ABaRK.

The project has successfully initiated awareness and adoption of the PMJJBY, PMSBY, and ABaRK schemes among Anganwadi workers and helpers. While challenges remain in achieving complete and accurate data collection, significant progress has been made in improving the tracking process. The initiative has strengthened the focus on health and insurance benefits for Anganwadi staff, with visible progress in the adoption of the ABaRK scheme. However, further efforts are required to ensure consistent and accurate reporting to fully realise the project's objectives.



Project Title: Teenage pregnancy data analysis

Project overview: The project involved analysing teenage pregnancies in Karnataka, identified from data indicating 12,000 cases in the state. The fellow reviewed and cleaned the data in collaboration with the WCD and shared an analysis and presentation with the Chief Secretary-GoK. KHPT (Karnataka Health Promotion Trust) was involved in planning actionable steps, including developing IEC (Information, Education, and Communication) material.

Status and way forward: Analysis of teenage pregnancies data lead to identification of high teenage pregnancy prevalence zones, enabling targeted interventions. Cabinet approved ₹5.45 crore budget for training and IEC activities. Fellow initiated initiatives for impactful content to combat teenage pregnancies and child marriages, gave recommendations for practical, scalable rollout plans, ensuring engagement from critical panchayat-level staff and requested ICPS to write to GoI for API integration of teenage pregnancies from RCH portal to ICPS CHL/Enhanced Surakshini application for faster action. The fellow strengthened partnerships among KHPT, WCD, ICPS, and stakeholders, paving the way for continued collaboration to address teenage pregnancy and related issues effectively.

Health and Family Welfare Department

Project Title: Leveraging advanced analytics for fraud detection and productivity enhancement in insurance claims management - SAST Team - HFW

Project overview: The Fellow is actively collaborating with the SAST (Suvarna Arogya Suraksha Trust) team in the Government of Karnataka to explore innovative technology solutions aimed at enhancing productivity and detecting potential fraud in insurance claims. Advanced reporting tools can significantly improve staff productivity by providing streamlined, real-time analytics. Tools offer high-level insights into patterns and anomalies, which are critical for identifying trends in potential fraud cases. This initiative demonstrates a commitment to leveraging cutting-edge technology to address systemic challenges and improve operational outcomes in Karnataka's healthcare insurance framework.

Status and way forward: Demo of advanced reporting tools with analytical insights completed. Triggers for auto detection of cases using AI has been agreed. Discussion on way forward and pilot ongoing.

Department of Youth Development and Sports

Project title: Youth Development Index (YDI) for Karnataka

Project overview: The Karnataka Youth Policy 2022 (KYP 2022) highlights that youth aged 15-29 make up 29% of the state's population, equating to approximately 2.11 crore individuals. To track progress in youth development, the Youth Development Index (YDI) will be introduced, measuring key areas such as education, health, and leadership, and aligning with the state's Sustainable Development Goals (SDGs). The YDI framework was developed by the Centre for Economic Studies and Policy (ISEC), Bengaluru, with input from the Department of Youth Empowerment and Sports (DYES) and other key stakeholders. The initiative aims to support data-driven policymaking for youth empowerment in Karnataka.

The fellow played a key role in analysing and aggregating data for the YDI's three primary focus areas: Education and Training, Health and Wellbeing, and Leadership Development. They also helped determine scaling factors for areas with limited data on the 15-29 age group, such as health and skill gaps. The draft YDI framework is now under review by the government for final approval.

Status and way forward: The Department will proceed once the YDI framework and indices are approved by the government.

Project title: Sports Hostels Management System (SHMS) and Management Information System (MIS) for the Department

Project overview: The Sports Hostels Management System (SHMS) and Management Information System (MIS) project aims to streamline operations and enhance oversight for the Department of Youth Empowerment and Sports (DYES), Karnataka. With 35 Sports Hostels and multiple schemes under its purview, DYES required an integrated software solution to consolidate and analyse district-level data, providing actionable insights on inclusivity, financial management, and program outcomes. Previously, data collection relied on manual processes, leading to inefficiencies and delays in decision-making.

The fellow played a pivotal role in coordinating requirement gathering for the software, collaborating with the Centre for Smart Governance (CSG), Department of Personnel and Administrative Reforms (DPAR), and DYES. Key responsibilities included evaluating the feasibility of repurposing existing software, liaising with vendors, and facilitating partnerships to ensure cost-effective solutions. This resulted in a unified software approach, combining MIS and SHMS functionalities for improved user experience and operational efficiency. The project achieved significant milestones, including finalising functional requirements and engaging stakeholders. The proposed system will enable near-real-time financial tracking, enhance monitoring of hostel operations, and provide detailed metrics on student health, academic, and sports performance, thereby driving better outcomes for the department.

Status and way forward: The Department of Youth Empowerment and Sports will engage the relevant vendors upon approval of the budget request by the State Government.

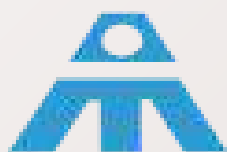
